ORDINANCE 2020-05 CONSENTING TO THE APPOINTMENT OF HAROLD DESANTOS AS THE FULL TIME VILLAGE ADMINISTRATOR FOR THE VILLAGE OF NEW HOLLAND, PICKAWAY COUNTY, OHIO AND SETTING THE RESIDENCY AND THE WAGE FOR THE POSITION AND DECLARING IT TO BE AN EMERGENCY

**WHEREAS,** Section (ref. 735.271 of ORC) the Village Administrator need not be an elector or reside in the village at the time of his appointment; however, Council has the power to approve that the Village Administrator may live outside of the Village, and do so approve that he can live outside of the Village of New Holland

WHEREAS, the Village of New Holland, Ohio is authorized by statute to establish wages for an Village Administrator thereto; and

**WHEREAS**, Section (ref. 731.08) of the Ohio Revised Code authorizes the Council of the Village of New Holland, to fix the compensation of Village Officials, for the Village of New Holland, Pickaway County, Ohio

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF NEW HOLLAND, OHIO, THAT:

**SECTION I:** In accordance with Ohio Revised Code, Section 735.271 authorizes the Council of the Village of New Holland, to approve that the Village Administrator may reside outside of the Village.

**SECTION II:** In accordance with Ohio Revised Code, Section 731.07 the salary of the Village Administrator shall be according to the Wage set by the council, with the amount of salary to be \$54,000.00. The Base salary is \$48,000.00 annually with the addition of \$6,000.00 annually for mandated ACA (medical) costs..

**SECTION III:** After probation period employee will be eligible for a cost of Living pay rate increase on their anniversary of up to 3%, and must be approved in the budget by Council each year, and

**SECTION IV:** That this Ordinance repeals any other existing Ordinances or Resolutions parts specifically in conflict with, herewith of the Village of New Holland, Ohio, are hereby repealed.

**SECTION V:** That this Ordinance is hereby declared to be an emergency measure and it is there by necessary for the preservation of the safety and welfare of the Village for the reason that said Village must have a Village Administrator and is in immediate need of the same, and said Ordinance shall take effect and be in force immediately upon its passage and approval.
