AN ORDINANCE AMENDING ORDINANCE 2018-05 PROVIDING FOR THE UPDATED WAGES OF PUBLIC UTILITY OPERATOR FOR WATER, SEWER AND STREETS IN THE VILLAGE OF NEW HOLLAND.

WHEREAS, Section 731-13 of the Ohio Revised Code authorizes the Council of the Village of New Holland, is authorized to fix the compensation of all employees of the Village of New Holland

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF NEW HOLLAND, OHIO, THAT:

Section I: That there is hereby created the position of full time Public Utility Operator for the Village of New Holland; and

**Section II:** That the compensation for the position of Public Utility Operator shall be according to yearly review by Village Administrator. Based on the review. the wage progression will be based on the following:
