

**ORDINANCE CONSENTING TO THE PERMANENT APPOINTMENT OF ALEX CHHUOM AS CHIEF OF POLICE FOR THE VILLAGE OF NEW HOLLAND AND DECLARING THIS TO BE AN EMERGENCY.**

**WHEREAS**, Section 737.15 of ORC mandates the appointment by the Mayor with advice and consent of the council: and

**WHEREAS**, The Mayor and Council by vote of the Village has appointed **ALEX CHHUOM** to the permanent position of Chief of Police, effective immediately.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF NEW HOLLAND, OHIO, THAT:**

**SECTION 1:** That in accordance with, and subject to all the restrictions of Section 737.15 and 737.16 of the Ohio Revised Code, the council of New Holland hereby consents to the appointment by the Mayor of **ALEX CHHUOM** as Chief of Police for the Village of New Holland, Ohio, effective immediately.

**SECTION 2:** This position will be Part Time and will not be compensated by a wage.

**SECTION 3:** The police chief will make the decision on the Officers that will be hired as part time.

**SECTION 5:** The Residency requirement has been waved per Ordinance 2018-04 and applies to **ALEX CHHUOM**.

**SECTION 6:** This Ordinance repeals any other Ordinances or Resolutions specifically in conflict with this Ordinance, of the Village of New Holland, Ohio, are hereby repealed.

**SECTION 7:** That in accordance with Section 731.36, this ordinance is necessary for the preservation of the health & safety of residents of the Village, in so far as there is a necessity to provide for daily management of the Police Department of the Village, and shall go into full force and effect immediately, upon passage by the council of the Village
