NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF NEW HOLLAND, OHIO, THAT:

SECTION 1: That in accordance with, and subject to all the restrictions of Section 737.15 and 737.16 of the Ohio Revised Code, the council of New Holland hereby consents to the appointment by the Mayor of **ALEX CHHUOM** as Chief of Police for the Village of New Holland, Ohio, effective immediately.

SECTION 2: This position will be Part Time and will not be compensated by a wage.
