

**AN ORDINANCE AMENDING ORDINANCE 2021-13. THE WATER RATES AND CHARGES FOR THE VILLAGE OF NEW HOLLAND, PICKAWAY COUNTY, STATE OF OHIO .**

**WHEREAS,** An Ordinance’s has established the water rates, and charges for the Village of New Holland Public Utility; and

**WHEREAS,** the Council of the Village of New Holland, Ohio is empowered by statute to establish the rates to be charged for water services within the Village of New Holland, Ohio and;

**WHEREAS,** the Council of the Village of New Holland, Ohio has determined that this Ordinance is an emergency measure and that the following modifications to the water rates, and charges for water services provided to the customers by the Village of New Holland Public Utility, and are immediately necessary for the preservation of the public health, peace, property, safety and welfare.

**NOW THEREFORE, BE IT ORDIANED BY THE COUNCIL OF THE VILLAGE OF NEW HOLLAND, OHIO, THAT:**

**SECTION I:**

- A. Type of Charge: There hereby established for the services rendered by the water system of the Village of New Holland, Ohio, the following rates and charges based upon the actual use of water through meters supplied by the said water department.
- B. Type of Users: Presently, users are residential or apartment residential and commercial users. Users are any person or entity connected to the water system.
- C. Water Deposit is required of \$100.00 before water is turned on for all owners or renters.
- D. Minimum water charge: The minimum charge for all water users **effective November 19, 2022 and with the first billing in December 2022,** shall be as follows:

**Water Rate Structure:**

**Residential:**

- \$30.15 Base charge,
- \$5.79 per 1000 gallons or fraction thereof

**Commercial:**

- \$34.22 Base charge,
- \$ 5.79 per 1000 gallons or fraction thereof

**Other Charges:**

- Trip Fees: shut off \$35.00. Turn on \$35.00
- Trip Fee/Hang Tag fee \$15.00 due on 4<sup>th</sup> hang tag within a Family plus 12 month period. \$1,800.00~Residential Outside - Commercial
- Late Fee 10% on unpaid balance not paid by 10<sup>th</sup> of month material
- Penalty for Tampering with water meter, \$200.00

**Residential Out of Corporation:**

- \$33.16 Base charge,
- \$6.08 per 1000 gallons or fraction thereof

**Commercial Out of Corporation:**

- \$37.62 Base charge,
- \$ 6.08 per 1000 gallons or fraction thereof

- Returned check, (NSF) \$40.00 ~ Automatic Shut-off
- Water tap fee, \$1,300.00~Residential Inside 2
  - Water tap fee,
- Material costs for repairs Actual Cost of

**Water Debt Reduction:**

- 11.75 ~ Water Plant, Water Tower, lines & meters (OWDA & OPWC Debt)
- \$2.25 ~ Water Maintenance / Improvements.

The charge for Water Debt will be billed to all **water services**, except government owned property monthly (water on or off).

- E. The Property owner are responsible for Excavation connection of tap and laterals by licensed plumber. The Owner is responsible for any disturbance of roadway, curbs, and sidewalks. It is highly encouraged to use plastic water lines.
- F. The Village will oversee the entire project while work is being done. Minimum water charge:

All Village of New Holland municipal owned properties are exempt from any water fees. The New Holland Cemetery is exempt from paying water and sewer fees as long as the building is unoccupied. Debt reduction fees will still be due monthly. Once the building is occupied as a residence, normal billing will resume.

**SECTION II:** Additional Increase in Rates: The water base and usage rates shall be reviewed annually every August to determine if a rate increase is needed starting January 1<sup>st</sup> the following year. If it is determined that a rate increase is needed, the increase shall not exceed 3%. Also, the determined rate from the August annual review must be voted on and passed by New Holland Village Council during the next scheduled village council meeting.

**SECTION III:** Ordinance 2021-13 and any other ordinances or resolutions or parts thereof which are in conflict or Inconsistent with any provision of the water base rates and charges are hereby repealed.

**SECTION IV:** Council has determined that the measures set forth herein are necessary for the protection of the public health, safety and welfare. As such, this Resolution must be passed as an emergency measure in the interest of the health, safety and general welfare of the residents of the Village.

**SECTION V:** That this Ordinance shall take effect and be in full force from and after the earliest period permitted by law.
