

A RESOLUTION AUTHORIZING THE MAYOR OF THE VILLAGE OF NEW HOLLAND, OHIO TO APPROVE EXPENDITURES FOR THE PURPOSE OF REPAIRING AND UPGRADING THE WASTEWATER TREATMENT PLANT AND DECLARING AN EMERGENCY

WHEREAS, the Village of New Holland desperately needs to repair and upgrade the wastewater treatment plant; and

WHEREAS, the Village of New Holland does have the funds available within its budget to pay for these repairs and upgrade; and

WHEREAS, the Mayor has recommended the passage of this Resolution as an emergency measure; as it is necessary for the immediate preservation of the public peace, health, safety, and property.

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of New Holland, Pickaway County, Ohio, as follows:

SECTION I: That this resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of said Village of New Holland for the reason that the repairs and upgrade of the wastewater treatment plant are needed as soon as possible. That this Resolution repeals any other existing Resolutions or parts specifically in conflict, herewith of the Village of New Holland, Ohio, are hereby repealed.
