

AN ORDINANCE APPROVING THE HIRING OF RANDY BRISETTE AS A CONTRACTOR AS THE LICENSED OPERATOR FOR THE WATER DEPARTMENT AND THE WASTEWATER TREATMENT PLANT AND, SETTING THE SALARY FOR THE POSITION AT ONE THOUSAND DOLLARS THREE HUNDRED AND NO CENTS (\$1,300.00) PER MONTH, FOR THE VILLAGE OF NEW HOLLAND PICKAWAY COUNTY, OHIO, AND DECLARING IT TO BE AN EMERGENCY

WHEREAS, it is necessary to provide a licensed operator for the usual daily operation of the municipality water and wastewater Plants and for the immediate preservation of the public peace, health, safety and general welfare of the municipality that this ordinance take effect at the earliest possible date, and

NOW THEREFORE, IS IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF NEW HOLLAND, OHIO, THAT:

SECTION 1: The Village of New Holland Council is authorized to set the Salary for the Licensed Operator.

SECTION 2: The rate of pay for the position as Licensed Operator is set at One Thousand and Three Hundred Dollars and no cents (\$1,300.00) per month. 50% will be paid from the Water Fund #5101 and 50% from Sewer Fund #5201.

SECTION 3: That this Ordinance repeals any other existing Ordinances or parts specifically in conflict, herewith of the Village of New Holland, Ohio, are hereby repealed.

SECTION 4. This ordinance is declared to be an emergency measure necessary for the immediate preservation of the peace, health, safety and general welfare of the people of this municipality, and shall take effect at the earliest date provided by law
