

**AN ORDINANCE FOR THE PERMANENT APPROPRIATIONS FOR CURRENT YEAR EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF NEW HOLLAND, STATE OF OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2024 . THIS IS TO REPLACE THE TEMPORARY APPROPRIATIONS AND IS AN EMERGENCY.**

SECTION 1: Be it ordained by the Council of the Village of New Holland, State of Ohio, that, to provide for the current expenses and other expenditures of the said Village of New Holland during the fiscal year ending December 31, 2024, the following sums are, and they are hereby set aside and appropriated as follows,

SECTION 2: That there be appropriated from the following funds, the sums as indicated:

SECTION 3: And the Village Fiscal Officer is hereby authorized to draw warrants for payments from any of the foregoing appropriations upon receiving proper certificates and vouchers therefore, approved by the board or officers authorized by law to approve the same, or an ordinance or resolution of council to make the expenditures; provided that no warrants shall be drawn or paid for salaries or wages except to persons employed by authority of and in accordance with law or ordinance. Provided further that the appropriations for contingencies can only be expended upon appeal of two-thirds votes of Council for items of expense constituting a legal obligation against the Village, and for purposes other than those covered by other specific appropriations herein made.

SECTION 4: That this Ordinance amends any other existing Ordinances or parts specifically in conflict, herewith of the Village of New Holland, Ohio, are hereby amended.

SECTION 5: This Ordinance is necessary for the immediate preservation of the public peace, health and safety of said Village of New Holland for the reason the immediate appropriations for Fiscal Year Ending

December 31, 2024 be done so as to pay invoices in a timely manner and shall take effect at the earliest period allowed by law.

SECTION 6: That this Ordinance shall take effect and be in force upon its passage and approval.
