

**AN ORDINANCE AMENDING ORDINANCE 2021-03 THE VILLAGE OF NEW HOLLAND PUBLIC UTILITIES POLICIES AND PROCEDURES FOR THE MUNICIPALITY OF THE VILLAGE OF NEW HOLLAND, PICKAWAY COUNTY, OHIO, AND DECLARING IT TO BE AN EMERGENCY**

**WHEREAS**, The prior Ordinances 2021-03 for Water and Wastewater Departments of the municipality require updates for a the complete preservation of the public peace, health, safety and general welfare of the municipality and employees and for the proper conduct of its affairs.

**WHEREAS**, it is necessary to provide for the usual daily operation of the municipality and for the immediate preservation of the public peace, health, safety and general welfare of the municipality that this ordinance take effect at the earliest possible date.

**NOW THEREFORE, IS IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF NEW HOLLAND, OHIO, THAT:**

**SECTION I:** The Public Utilities Department for the Village of New Holland must have a consistent and definite way to administer policies and procedures for all subscribers of the water and wastewater system.

**SECTION II:** One copy of the Policies and Procedures will be kept in the Village Administrators Office and one copy will be kept in the Public Utility Billing Clerks Office. An original copy of the Policies and Procedures will be kept in the Fiscal Officers office. Any changes to the original manual will be approved and voted on by Council Members of the Village of New Holland. Any Major changes to the manual will constitute a revised Ordinance. Minor changes can be made on an individual page and marked as such on the page with approval by council.

**SECTION III:** Ordinance 2021-03 and any other ordinances or resolutions or parts thereof which are in conflict or inconsistent with any provision of the Policies and Procedures are hereby repealed.

**SECTION IV** This ordinance is declared to be an emergency measure necessary for the immediate preservation of the peace, health, safety and general welfare of the people of this municipality, and shall take effect at the earliest date provided by law

**SECTION V:** This resolution shall go into full force and effect upon passage by the Council of the Village of New Holland, Pickaway County, Ohio.
