

**A RESOLUTION AUTHORIZING THE FISCAL OFFICER TO ESTABLISH A NEW FUND, 5724 FOR THE OWDA LOAN 8415 FOR THE WTP IRON FILTER REPLACEMENT.**

**WHEREAS**, the Village of New Holland Council must authorize the establishment of new Funds.

**NOW THEREFORE, BE IT RESOLVED** by the Council of the Village of New Holland, Pickaway County, Ohio, as follows:

**SECTION I:** That the Fiscal Officer is authorized by Council to establish the following new Fund in the UAN (Uniform Accounting Network).

- 1. Fund 5724 ~ OWDA Loan 8415 WTP IRON FILTER REPLACEMENT PROJECT.

**SECTION II:** That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of said Village of New Holland for the reason that payment to the OPWC for the WTP Iron Filter replacement is due to begin January 1, 2021 and is necessary in order to track the principle and interest of the debt; wherefore, this ordinance shall be in full force and effect from and immediately after its passage.
