

**A RESOLUTION AUTHORIZING THE FISCAL OFFICER TO ESTABLISH A NEW FUND, 5725 FOR THE OHIO PUBLIC WORKS LOAN CQ36T FOR THE WWTP SPIRAL SCREEN STATION. THIS IS AN EMERGENCY.**

**WHEREAS**, the Village of New Holland Council must authorize the establishment of new Funds.

**NOW THEREFORE, BE IT RESOLVED** by the Council of the Village of New Holland, Pickaway County, Ohio, as follows:

**SECTION I:** That the Fiscal Officer is authorized by Council to establish the following new Fund in the UAN (Uniform Accounting Network).

- 1. Fund 5725 ~ OPW Loan CQ36T WWTP SPIRAL SCREEN STATION.

**SECTION II:** That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of said Village of New Holland for the reason that payment to the OPW for the WWTP Spiral Screen Station is due to begin January 31, 2021 and is necessary in order to track the principle and interest of the debt; wherefore, this ordinance shall be in full force and effect from and immediately after its passage.
