

A RESOLUTION AUTHORIZING THE FISCAL OFFICER TO ESTABLISH NEW FUNDS, FOR CAPITAL IMPROVEMENT FUNDS 4907 FOR CRITICAL INFRASTRUCTURE GRANT, 4908 FOR THE COMMUNITY REVIVAL GRANT, AND 4909 PICKAWAY COUNTY PARKS AND TRAILS AND DECLARING THIS TO BE AN EMERGENCY.

WHEREAS, the Village of New Holland Council must authorize the establishment of new Funds

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of New Holland, Pickaway County, Ohio, as follows:

SECTION I: That the Fiscal Officer is authorized by Council to establish the following new Funds in the UAN (Uniform Accounting Network).

- 1. Fund 4907 ~ Capital Improvement for the Critical Infrastructure Development and .
2. Fund 4908 ~ Capital Improvement for the Community Revival.
3. Fund 4909 ~ Capital Improvement for the Pickaway County Parks and Trails

SECTION II: That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of said Village of New Holland for the reason that the immediate construction of the S East St, Allen Ave, Ramp at Village Hall, Park revitalization, Trail around pond, Aerator at pond, sidewalk from N. Main Street to cemetery. The improvements to begin at the earliest possible time is necessary in order to protect the safety of the inhabitants of the Village by providing improved environment ; wherefore, this ordinance shall be in full force and effect from and immediately after its passage.
