WHEREAS, The Village of New Holland needs to have access to the North Valley Bank lockbox.

WHEREAS, The Village of New Holland authorizes North Valley Bank to make the changes adding the Mayor Joe Inskeep, Fiscal officer Carmen White, and Village Administrator Harold DeSanto only to have access to the lockbox.
