

A RESOLUTION, AUTHORIZING THE VILLAGE OF NEW HOLLAND TO ENTER INTO AN AGREEMENT WITH COX PAVING OF WASHINGTON COURTHOUSE, OHIO., TO COMPLETE THE REPAIR ON SOUTH MAIN PROJECT AND DECLARING AN EMERGENCY.

WHEREAS, The Village of New Holland is make improvements to the South Main roadway including adding base and asphalt with a Grant Ohio Public Works Commission; and

WHEREAS, The infrastructure improvement herein above described is considered to be a priority need of the Village of New Holland and has qualified the project under the OPWC, grant programs; and

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF NEW HOLLAND, THAT:

SECTION I: That the Village of New Holland Council, Pickaway County, Ohio does authorize Cox Paving LLC, to proceed with the repair on south main street.

This resolution shall take effect at the earliest period allowed by law.
