

A RESOLUTION AUTHORIZING THE PICKAWAY COUNTY AUDITOR TO CERTIFY THE AMOUNTS THAT A 1 MIL NEW LEVY FOR THE CURRENT EXPENSE OPERATING FUND WOULD BRING INTO THE VILLAGE OF NEW HOLLAND.

WHEREAS, The Council of the Village of New Holland, Ohio has determined that they need a new GENERAL OPERATING FUND levy on the November 2021 ballot: and

WHEREAS, It will not be detrimental to the general interest to request that the Pickaway County Auditor certify the amounts; and

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF NEW HOLLAND, THAT:

SECTION I: That the Council of the Village of New Holland, Pickaway County, Ohio, does authorize the Pickaway County Auditor to certify the amounts a 1 mil General Operating Fund new Levy would be; and will be for the General Operating Fund, taxable for the tax years 2021, 2022, 2023, 2024 and 2025, payable in calendar years 2022, 2023, 2024, 2025 and 2026.

SECTION II: This Resolution is passed pursuant to Section 5705.19(A) of the Ohio Revised Code.

SECTION III: This Resolution is to complete the requirements of the State of Ohio law that the Auditor must certify the amounts of the levies before they will be accepted by the Board of Elections and that a Resolution is required to receive the certifications from the County Auditor and must be passed by Council before the Ordinances are passed to place the levies on the ballot: and

SECTION IV: That this Resolution repeals any other existing Resolutions or parts specifically in conflict, herewith of the Village of New Holland, Ohio, are hereby repealed.

SECTION V: This Resolution is declared to be an emergency measure in order to meet the deadline for submission to the Board of Elections for the November 2, 2021 election and for the general health, safety, and welfare of the citizens of the Village of New Holland: and shall go into full force and effect upon passage by the Council of the Village of New Holland, Pickaway County, Ohio.
