

**A RESOLUTION TO AUTHORIZE THE FISCAL OFFICER OF THE VILLAGE OF NEW HOLLAND TO DO TRANSFERS OF TWELVE THOUSAND NINE HUNDRED TWO DOLLARS AND TWENTY-SIX CENTS (\$12,902.26) AND ONE THOUSAND FIVE HUNDRED FIFTY ONE DOLLARS AND FIFTY TWO (\$1,551.52) FROM THE COMMUNITY CENTER FUND 2042 AND COMMUNITY CENTER BUILDING REPAIR FUND 2043 TO FUND 1000 FOR THE GENERAL SUPPORT FOR THE VILLAGE OF NEW HOLLAND'S, AND DECLARING IT TO BE AN EMERGENCY**

WHEREAS, The Council of the Village of New Holland, Pickaway County, Ohio, has determined that there is a need to allow the Fiscal to make a transfer from the Community Center Fund and the Community Center Building Repairs Fund to the fund for its share general support of the Village and to repay costs associated with the Center paid by the General Fund.

WHEREAS, The Council of the Village of New Holland is empowered by statute to authorize, the Fiscal Officer to move funds from the Community Center Fund and the Community Center Building Repairs Fund to the Fund 1000 General Fund.

**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF NEW HOLLAND, THAT:**

**SECTION I:** That this resolution is thereby necessary to allow the Fiscal Officer to make a transfers from the Community Center Fund and the Community Center Building Repairs Fund to the Fund 1000 General Fund. This Resolution shall take effect, and be in force immediately upon its passage and approval by the Council.

**SECTION II:** That this resolution is thereby necessary for the preservation of the welfare of the Citizens of the Village of New Holland. It will permit the repayment of the costs associated with the Community Center. This Resolution shall take effect and be in force immediately upon its passage and approval by the Council.

**SECTION III:** This resolution shall go into full force and effect upon passage by the Council of the Village of New Holland, Pickaway County, Ohio.
