

A RESOLUTION AUTHORIZING MAYOR JOE INSKEEP TO PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO WATER AND WASTEWATER INFRASTRUCTURE GRANT PROGRAM AND TO EXECUTE CONTRACTS AS REQUIRED AND DECLARING AN EMERGENCY

WHEREAS, The Water and Wastewater Infrastructure Grant provides financial assistance to political subdivisions for capital improvements to improve access to clean drinking water and wastewater infrastructure and

WHEREAS, the Village of New Holland, Pickaway County, Ohio is planning to make capital improvements to Effluent Lift Station Upgrade, and

WHEREAS, the infrastructure improvement herein above described is considered to be a priority need for the community and is a qualified project under the Water and Wastewater Infrastructure Grant program,
