

**A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT FOR EMERGENCY MEDICAL SERVICES BETWEEN FAYETTE COUNTY EMS DISTRICT, THE VILLAGE OF NEW HOLLAND, OHIO, AND DECLARING AN EMERGENCY**

**WHEREAS**, the Village of New Holland desires to secure an independent contractor to provide ambulance services as needed; and

**WHEREAS**, prior to this Agreement the Village has entered into an agreement independently with Fayette County EMS District for emergency medical services and emergency ambulance services to the residents of the Village; and

**WHEREAS**, the voters of the Village did approve at the November 5, 2019 general election a five (5) year levy of 1.5 mils for provision of such services to the entire Village territory (“EMS levy”); and,

**WHEREAS**, the mayor deems it necessary and advisable for the public health, safety and welfare that such services be made available to all residents of the Village to include those residents who reside in those portions of the Village that are located in both Fayette and Pickaway Counties, and, therefore, has recommended the passage of this Resolution as an emergency measure.

**NOW THEREFORE, BE IT RESOLVED** by the Council of the Village of New Holland, Pickaway County, Ohio, as follows:

**SECTION I:** That this resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of said Village of New Holland for the reason that the agreement needs to take effect as soon as possible. That this Resolution repeals any other existing Resolutions or parts specifically in conflict, herewith of the Village of New Holland, Ohio, are hereby repealed.
