

AN RESOLUTION AUTHORIZING THE FISCAL OFFICER TO SPEND THE ARPA MONEY UP TO \$89,143.15 FROM APRIL 1, 2022 TO DECEMBER 2025 FOR EQUIPMENT AND LABOR TO SUPPORT THE VILLAGE OF NEW HOLLAND DURING THE COVID-19 PANDEMIC. THE MONEY WILL BE SPENT IN ACCORDANCE WITH THE AGREEMENT OF THE FINANCE COMMITTEE FOR THE BENEFIT THE VILLAGE OF NEW HOLLAND, PICKAWAY COUNTY, OHIO, AND DECLARING THIS TO BE AN EMERGENCY

WHEREAS, The Council of the Village of New Holland, Pickaway County, Ohio, has determined that there is a need to authorize the Fiscal Officer to spend up \$89,143.15 from April 1, 2022 to December 2025 to purchase equipment and labor relating to support infrastructure and support work needed during the pandemic that benefit the Village of New Holland, Pickaway County, Ohio; and

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF NEW HOLLAND, THAT:

SECTION I: That the Village of New Holland Council, Pickaway County, Ohio does authorize the Fiscal Officer to make purchases based on the plans and agreement of the Finance Committee, and

SECTION II: That this Resolution is declared to be an emergency measure necessary for the preservation of the safety and welfare of the citizens of the Village of New Holland and this resolution shall go into full force and effect upon passage by the Council of the Village of New Holland, Pickaway County, Ohio.
