

A RESOLUTION AUTHORIZING THE PICKAWAY COUNTY AUDITOR TO CERTIFY THE AMOUNTS THAT A 1.0 MIL RENEWAL LEVY FOR THE CEMETERY WOULD BRING INTO THE VILLAGE OF NEW HOLLAND

WHEREAS, The Council of the Village of New Holland, Ohio has determined that they need to renew the cemetery levy on the November 2022 ballot; and

WHEREAS, it will not be detrimental to the general interest to request that the Pickaway County Auditor certify the amounts; and

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF NEW HOLLAND, THAT:

SECTION I: That the Council of the Village of New Holland, Pickaway County, Ohio, does authorize the Pickaway County Auditor to certify the amounts a 1.0 mil Cemetery Renewal Levy would be; and will be for the general operating of the Cemetery, taxable for the tax years 2023, 2024, 2025, 2026 and 2027, payable in the calendar years 2024, 2025, 2026, 2027 and 2028: and

SECTION II: This Resolution is passed pursuant to Section 5705.19(T) of the Ohio Revised Code.

SECTION III: This Resolution is to complete the requirements of the State of Ohio law that the Auditor must certify the amounts of the levies before they will be accepted by the Board of Elections and that a Resolution is required to receive the certifications from the County Auditor and must be passed by Council before the Ordinances are passed to place the levies on the ballot: and

SECTION IV: That this Resolution and any other existing Resolutions or parts specifically in conflict, herewith of the Village of New Holland, Ohio, are hereby repealed.

SECTION V: This Resolution shall go into full force and effect upon passage by the Council of the Village of New Holland, Pickaway County, Ohio.
