

**A RESOLUTION AUTHORIZING SKYCHARGE ENERGY TO WORK WITH AES TO INSTALL SWITCH COMPANY EV EQUIPMENT AND NETWORKING AT THE DESIGNATED LOCATION AT THE NEW HOLLAND TOWN HALL. THE TOTAL COST OF THE INSTALLATION IS \$29,349. OF THAT THE AMOUNT OF ONLY \$20,000 WILL BE COVERED IN THE AES EVSE REBATE PROGRAM LEAVING THE VILLAGE OF NEW HOLLAND TO PAY THE REMANDER OF \$9,349. AND DECLARING IT TO BE AN EMERGENCY.**

**WHEREAS**, the AES Program to provide financial assistance to political subdivisions for capital improvements to public infrastructure, and

**WHEREAS**, the Village of New Holland is planning to make capital improvements to the New Holland Streets Improvement and Community Park Improvement, and

**WHEREAS**, the infrastructure improvement herein above described is a priority need for the community and is a qualified project under the AES programs,

**NOW THEREFORE, BE IT RESOLVED** by the Council of the Village of New Holland, Pickaway County, Ohio, as follows:

**SECTION I:** The Skycharge Energy company is hereby authorized to install the EV equipment at the Town Hall location approved by Council and using AES for rebate funds as described above.

**SECTION II:** The Mayor, Village Administrator or Village Fiscal Officer is authorized to enter into any agreements as may be necessary and appropriate for obtaining this financial assistance.

**SECTION III:** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this resolution were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with the law.

**SECTION IV:** That this Resolution is declared to be an emergency measure necessary secure funding and for the preservation of the safety and welfare of the citizens of the Village of New Holland and this Resolution must be presented to the Skycharge Energy and SWITCH Company so that this Resolution shall take effect and be in force immediately upon its passage and approval by the Mayor.
