

AN RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO HAVE WELL #1 CLEANED AND MAINTAINED FROM THE WATER DEPARTMENT FUND 5602, ACCORDING TO WHERE THE CHARGES WILL BE INCURRED, TO ENABLE BETTER QUALITY DRINKING WATER. IN ADDITION, IT IS MANDATED BY THE OHIO EPA THAT THE WELLS BE CLEANED AND MAINTAINED AT LEAST EVERY 5 YEARS FOR THE VILLAGE OF NEW HOLLAND, PICKAWAY COUNTY, OHIO, AND DECLARING THIS TO BE AN EMERGENCY

WHEREAS, The Council of the Village of New Holland, Pickaway County, Ohio, has determined that there is a need to authorize the Village Administrator to spend up \$19,370 with MOODY’S OF DAYTON INC for the cleaning and maintenance of well #1 at the Water Treatment Plant to benefit the Village of New Holland, Pickaway County, Ohio; and

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF NEW HOLLAND, THAT:

SECTION I: That the Village of New Holland Council, Pickaway County, Ohio does authorize the Village Administrator to make purchases for cleaning and maintenance of Water Well 1 for \$19,370. This work will start May 2023,

SECTION II: That this Resolution is declared to be an emergency measure necessary for the preservation of the safety and welfare of the citizens of the Village of New Holland and this resolution shall go into full force and effect upon passage by the Council of the Village of New Holland, Pickaway County, Ohio.
