

**A RESOLUTION OF NECESSITY DETERMINING TO PROCEED WITH THE SUBMISSION TO THE ELECTORS OF THE QUESTION OF LEVYING AN ADDITIONAL TAX IN THE AMOUNT OF 1.5 MILLS IN EXCESS OF THE 10 MILL LIMITATION TO RUN FOR A DEFINITE PERIOD OF FIVE (5) YEARS FOR THE PURPOSE OF THE STREET OPERATING FUND WOULD BRING WITHIN THE VILLAGE OF NEW HOLLAND, AND DECLARING THIS TO BE AN EMERGENCY**

**WHEREAS**, The Council of the Village of New Holland, Pickaway County, Ohio, has determined that there is a need to authorize the Pickaway County Board of elections to submit to the elector of the Village of New Holland an additional levy for the operations of the New Holland Current expenses general fund, B. Washburn certify the amounts that a levy to be placed on the November 7, 2023 ballot

**WHEREAS**, the County Auditor has certified to the Village that the total current tax valuation of the Village of New Holland is \$12,510,400 and the dollar amount of revenue that will be produced annually by the millage stated below would be \$19,000.00 (Attached as Exhibit A); and

**WHEREAS**, the Council of the Village of New Holland is desirous of proceeding with the submission to the electors of the question of levying an additional tax in the amount of 1.5 mills in excess of the 10 mill limitation for the purpose of the Street operating expenses in the general fund;

**WHEREAS**, On May 17, 2023 the Village Council adopted a Resolution to submit to the electors of the Village of New Holland an additional Levy for operation of the Street fund Outside the ten-mill limitation, and

**WHEREAS**, The Pickaway County Auditor has certified to the Village Council that the total current tax valuation of the Village of New Holland is \$.0015 Mil for each one dollar of valuation of revenue that will be produced annually by the millage stated for 5 years would be \$19,000 per Year

**WHEREAS**, It is necessary to levy an additional tax in excess of the ten-mill limitation on the taxable property of the Village of New Holland, Pickaway County, Ohio, for a definite period of five (5) years (tax year 2023, 2024, 2025, 2026, 2027) at a rate authorized by law for the purpose of general operating expenses in the general fund in the Village of New Holland;

**NOW THEREFORE, BE IT RESOLVED** by the Council of the Village of New Holland, Pickaway County, Ohio, as follows:

**SECTION I:** That the Council of the Village of New Holland desires and determines to proceed with the submission to the electors of the question of levying an additional tax in excess of the 10 mill limitation for the purpose of Road Improvement expenses for the Street Fund at a rate not exceeding 1.5 mills for each \$1.00 of valuation, which amounts to fifty-three dollars (\$53) for each one hundred thousand dollar (\$100,000.00) valuation of the taxable property within the Village of New Holland for a period of five (5) years (tax years 2024, 2025, 2026, 2027, 2028) of time to be levied in 2024 and collected in 2025, 2026, 2027, 2028, and 2029 as permitted in Ohio Revised Code Section 5705.19.

**SECTION II:** This Resolution is passed pursuant to **Section 5705.19(A)** of the Ohio Revised Code.

**SECTION III:** That the Fiscal Officer of the Village of New Holland be, and hereby is, directed to certify a copy of this resolution to the Board of Elections of Pickaway County, Ohio, not less than ninety (90) days before election, and notify said Board to cause proper notice of the election, pursuant to Ohio Revised Code Section 5705.25, and submit the question of such taxation to all electors with the Village of New Holland, Pickaway County, Ohio at the general election to be held the November 7, 2023, as provided by law.

**SECTION IV:** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this resolution were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with the law.

**SECTION V:** That this Resolution repeals any other existing Resolutions or parts specifically in conflict, herewith of the Village of New Holland, Ohio, are hereby repealed.

**SECTION VI:** This this Resolution shall take effect and be in force from and after the earliest period permitted by law.
