A RESOLUTION AUTHORIZING THE PICKAWAY COUNTY AUDITOR TO CERTIFY THE AMOUNTS THAT A .7 MIL RENEWAL LEVY FOR THE STREET OPERATING FUND WOULD BRING INTO THE VILLAGE OF NEW HOLLAND, AND DECLARING THIS TO BE AN EMERGENCY

WHEREAS, The Council of the Village of New Holland, Ohio has determined that they need to place an additional levy for the Street Operating Fund at the General Election on Nov 7, 2023 ballot; and

WHEREAS, it will not be detrimental to the general interest to request that the Pickaway County Auditor certify the amounts; and

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF NEW HOLLAND, THAT:

**SECTION I:** That the Council of the Village of New Holland, Pickaway County, Ohio, does authorize the Pickaway County Auditor to certify the amounts a .7 mil Street Operating Renewal Levy would be; and will be for the Street Operating Fund, taxable for the tax years 2024, 2025, 2026, 2027 and 2028, payable in calendar years 2025, 2026, 2027, 2028 and 2029.

**SECTION II:** This Resolution is passed pursuant to Section 5705.19(G) of the Ohio Revised Code.

**SECTION III:** This Resolution is to complete the requirements of the State of Ohio law that the Auditor must certify the amounts of the levies before they will be accepted by the Board of Elections and that a Resolution is required to receive the certifications from the County Auditor and must be passed by Council before the Ordinances are passed to place the levies on the ballot: and

**SECTION IV:** That this Resolution repeals any other existing Resolutions or parts specifically in conflict, herewith of the Village of New Holland, Ohio, are hereby repealed.

**SECTION V:** That this Resolution is declared to be an emergency measure necessary for the preservation of the safety and welfare of the citizens of the Village of New Holland, so that this Resolution shall take effect and be in force immediately upon its passage and approval by the Mayor.
