

A RESOLUTION, TO REQUEST A GRANT FROM THE PICKAWAY COUNTY PARK DISTRICT CREATE A MASTER PLAN DETAILING HOW TO IMPROVE THE VILLAGE OF NEW HOLLAND PARK TO ENABLE COMMUNITY ACTIVITIES AND DETERMINE COMMUNITY NEEDS AND DECLARING THIS TO BE AN EMERGENCY.

SECTION I: WHEREAS, the Pickaway County Park District administers a financial assistance program for public outdoor recreation purposes, through the 2024 Park and Trail Grant Program, and

SECTION II: WHEREAS, the ___ Village of New Holland ___ desires financial assistance under the Park and Trail Grant Program.

- 2) That ___ Mayor of the Village of New Holland, or President Pro-Tem Joe Inskeep ___ is hereby authorized and directed to execute and file an application with the Pickaway County Park District and to provide all information and documentation required to become eligible for possible funding assistance.
- 3) That the ___ Village of New Holland _ is aware and supportive of the proposed project and has the necessary funds appropriated in its 2024 budget to complete the project as outlined in this grant application, should the grant request be awarded.


