

A RESOLUTION AUTHORIZING THE VILLAGE OF NEW HOLLAND MAYOR AND FISCAL OFFICER TO ENTER INTO A LEASE AGREEMENT WITH FIRST GOVERNMENT LEASE COMPANY P.O. BOX 8331 NORTHFIELD ILL, 60093 TO LEASE TO PURCHASE A 2019 CHEVROLET TAHOE POLICE CRUISER FOR THE VILLAGE OF NEW HOLLAND, PICKAWAY COUNTY, OHIO, AND DECLARING THIS TO BE AN EMERGENCY

WHEREAS, the Village of New Holland Council has decided that there is a need to lease to purchase a police cruiser to replace one of the current police cruisers (2014 white Ford Explorer).

WHEREAS, It will not be detrimental to the general interest to enter into an agreement with First Government Lease Company for a police cruiser; and

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF NEW HOLLAND, THAT:

SECTION I: That the Council of the Village of New Holland Council, Pickaway County, Ohio does authorize the Mayor and Fiscal Officer to enter into agreement with First Government Lease Company for the lease to purchase of a police cruiser not to exceed \$25,600.00 (Twenty Five Thousand, Six Hundred Dollars and no cents, and

SECTION II: That the 2014 white Ford Explore will be traded in and will payoff current loan and that any money left over will be used towards the purchase of the new 2019 Chevy Tahoe Police cruiser.

SECTION V: This Resolution is necessary for the immediate preservation of the public peace, health and safety of said Village of New Holland for the reason that there is a need for a better police cruiser and should be done and shall take effect at the earliest period allowed by law.


