

A RESOLUTION AUTHORIZING THE VILLAGE OF NEW HOLLAND MAYOR AND FISCAL OFFICER TO ENTER INTO A CONTRACT WITH DLZ FOR A DESIGN, PLANNING, AND BIDDING SERVICES FOR THE WATER SYSTEM IMPROVEMENT PROJECT. THIS DESIGN FEE WILL NOT EXCEED ONE HUNDRED AND FIFTY THOUSAND DOLLARS (\$150,000) FOR THE VILLAGE OF NEW HOLLAND, PICKAWAY AND FAYETTE COUNTIES AND DECLARING IT AN EMERGENCY.

WHEREAS, The Village of New Holland Council has decided that there is a need to enter into a contract with DLZ Engineering, 30661 Red Rock Court Logan, OH_43138

WHEREAS, , it will not be detrimental to the general interest of the Village of New Holland

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF NEW HOLLAND, THAT:

SECTION I: That the Council of the Village of New Holland Council, Pickaway County AND Fayette County, Ohio does authorize the Mayor and Fiscal Officer to enter into a contract with the DLZ Engineering, and

SECTION II: This Resolution is passed pursuant to Section 5705.19(T) of the Ohio Revised Code.

SECTION III: That any other existing Resolutions or parts specifically in conflict with this resolution, herewith of the Village of New Holland, Ohio, are hereby repealed.

SECTION IV: This Resolution is necessary for the immediate preservation of the public peace, health and safety of said Village of New Holland to improve the efficiency operation of the sewer plant. and shall take effect at the earliest period allowed by law.


