

A RESOLUTION TO REQUEST A GRANT FROM THE PICKAWAY COUNTY PARK DISTRICT IMPROVE THE VILLAGE OF NEW HOLLAND PARK TO ENABLE COMMUNITY ACTIVITIES AND DECLARING THIS TO BE AN EMERGENCY.

SECTION I: WHEREAS, the Pickaway County Park District administers a financial assistance program for public outdoor recreation purposes, through the 2026 Park and Trail Grant Program, and

SECTION II: WHEREAS, the __ Village of New Holland __ desires financial assistance under the Park and Trail Grant Program.

NOW, THEREFORE, be it resolved by the Village of New Holland

- 1) That the Village of New Holland approves filing an application for financial assistance.
- 2) That Village of New Holland Village Administrator Harold DeSanto is hereby authorized and directed to execute and file an application with the Pickaway County Park District and to provide all information and documentation required to become eligible for possible funding assistance.
- 3) That the Village of New Holland is aware and supportive of the proposed project and has the necessary funds appropriated in its 2026 budget to complete the project as outlined in this grant application, should the grant request be awarded.


