

**AN ORDINANCE AUTHORIZING THE MAYOR, FISCAL CLERK AND VILLAGE ADMINISTRATOR OF THE VILLAGE OF NEW HOLLAND, PICKAWAY COUNTY, OHIO, TO ENTER INTO A CONTRACT WITH WHITT LAW OFFICE LLC. FOR THE EMPLOYMENT OF LEGAL COUNSEL INVOLVING PROSECUTORIAL FUNCTIONS AND DECLARING THIS TO BE AN EMERGENCY**

**WHEREAS,**

Whitt Law Office, LLC (through the services of K. Danielle Whitt, Attorney at Law), (Attorney), located at 127 N. High St., Hillsboro, OH 45133. and the Village of New Holland, Ohio (on the date last executed below. will serve as the statutory legal council of the Village of New Holland, Corporation of Pickaway & Fayette Counties pursuant to R. C. 705.11

**WHEREAS,** The Whitt Law Office, LLC., Attorney and Councilors, Hillsboro, OH, is duly authorized to practice in the State of Ohio, and;

**WHEREAS,** Pursuant to the Ordinances of the Village and the laws of the State of Ohio, the Village hereby retains Whitt Law Office, LLC to serve as legal counsel for the Village, its officials (elected and appointed), and its employees. As legal counsel, Whitt Law Office, LLC shall be responsible for performing all duties pursuant to Village Ordinances and the laws of the State of Ohio.

**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF NEW HOLLAND, THAT:**

**SECTION 1:** That the Mayor and Village Administrator be, and they hereby are, authorized to enter into a Contract with Whitt Law Office, LLC Attorneys at Law, to serve the Village as its legal counsel for civil representation as well as in matters involving prosecutorial functions, which shall include, but not be limited to, the handling of traffic citations issued by any law enforcement agency of the Village of New Holland, being prosecuted through the Circleville Municipal Court, Circleville, Pickaway County, Ohio and/ or the Village of New Holland Magistrate Court. As compensation for this representation, the Whitt Law Office, LLC Attorney at Law, agrees to accept the rate of compensation as stated in the Engagement of Legal Services: starting Jan 1<sup>st</sup> 2026 for all work performed in regard to fulfilling the duties as heretofore set forth for time incurred both out of Court as -well as for appearing before the Court, administrative tribunals, or other agencies wherein said appearances are a contested nature.

**SECTION 2:** This Ordinance is declared to be an emergency measure necessary to the immediate preservation of the public health, peace, safety and welfare of the Village, or providing for the usual daily operation of a municipal utility department and for the further reason that prompt action is necessary to protect the public and the Village; wherefore, this Ordinance shall be in full force and effect from and immediately after its passage and approval by the Mayor;




