

A RESOLUTION SELECTING TIM OOTEN FOR MEMBERSHIP ON THE PICKAWAY COUNTY 9-1-1 PROGRAM REVIEW COMMITTEE.

WHEREAS, the County of Pickaway has a 9-1-1 program review committee; and

WHEREAS, Ohio Revised Code section 128.06 provides that every county 9-1-1 program review committee shall consist of six members, one of whom is a member of the legislative authority of a municipal corporation in the county selected by the majority of the legislative authorities of municipal corporations in the county pursuant to resolutions they adopt;

NOW THEREFORE, BE IT RESOLVED by the Village of New Holland, that:

Section 1. The Village Council selects Tim Ooten , a member of the legislative body of the Village of South Bloomfield to serve on the Pickaway County 9-1-1 Program Review Committee, as described in section 128.06 of the Revised Code .

Section 2. The Clerk is directed to send a copy of this Resolution to Tiffany Nash, 911 Coordinator and Director of the Pickaway County Emergency Management Agency.

Section 3. It is found and determined that all formal actions by the Village Council concerning and relating to the adoption of this Ordinance were conducted in an open meeting of the Village Council and that all deliberations of the Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements with Section 121.22 of the Ohio Revised Code.

Section 4. This Ordinance shall become effective at the earliest time permitted by law.
