

A RESOLUTION AUTHORIZING THE VILLAGE OF NEW HOLLAND MAYOR AND FISCAL OFFICER TO ENTER INTO A CONTRACT WITH DLZ FOR DESIGN, PLANNING, AND BIDDING SERVIC FOR THE PAVING PROJECT TO INCLUDE CIRCLE AVE, CHURCH ST. THIS DESIGN FEE WILL NOT EXCEED TWENTY NINE THOUSAND SEVEN HUNDRED AND NINETY THREE DOLLARS (\$29,793.00) FOR THE VILLAGE OF NEW HOLLAND, PICKAWAY AND FAYETTE COUNTIES AND DECLARING IT AN EMERGENCY.

WHEREAS, The Village of New Holland Council has decided that there is a need to enter into a contract with DLZ Engineering, 30661 Red Rock Court Logan, OH_43138

WHEREAS, , it will not be detrimental to the general interest of the Village of New Holland

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF NEW HOLLAND, THAT:

SECTION I: That the Council of the Village of New Holland Council, Pickaway County AND Fayette County, Ohio does authorize the Mayor and Fiscal Officer to enter into a contract with the DLZ Engineering, and
