

RESOLUTION FOR ADOPTING THE FAYETTE COUNTY MITIGATION PLAN 2026 AND DECLARING IT TO BE AN EMERGENCY

WHEREAS the Village Council of New Holland recognizes the threat that natural hazards pose to people and property within the Village of New Holland; and

WHEREAS the Fayette County Emergency Management Agency has prepared a multi-hazard mitigation plan, hereby known as the Fayette County Mitigation Plan 2026 in accordance with federal laws, including the Robert T. Stafford Disaster Relief and Emergency Assistance Act, as amended; the National Flood Insurance Act of 1968, as amended; and the National Dam Safety Program Act, as amended; and

WHEREAS the Fayette County Mitigation Plan 2026 identifies mitigation goals and actions to reduce or eliminate long-term risk to people and property in the Village of New Holland from the impacts of future hazards and disasters; and

WHEREAS adoption by the Village Council of New Holland demonstrates its commitment to hazard mitigation and achieving the goals outlined in the Fayette County Mitigation Plan 2026.

NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE OF NEW HOLLAND, OHIO, THAT:








